



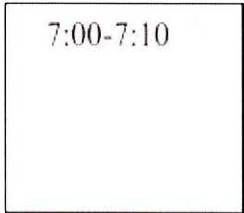

- B. - C. For the purpose of addressing G.L. c. 30A, § 21(a)(2) “to conduct strategy sessions in preparation for negotiations with nonunion personnel or to conduct collective bargaining sessions or contract negotiations with nonunion personnel” – secretarial and administrative support positions, information technology positions, non-union administrators, and/or the Superintendent of Schools (“Purpose 2”)
