Call to order at 7:00 PM by Ms. O'Connor using a meeting notice with attachments dated September 13, 2016.

On a motion by Ms. Karp and second by Mr. Rutigliano, the Committee voted to accept the minutes of August 18, 2016.

Ms. O'Connor announced that the public hearing on the Special Town Meeting warrant was in session. Copies of the memo to Town Meeting members dated September 12, 2016, were made available.

Article 1 - Mr. Lukach presented his proposal to the Committee and Mr. Morgado responded. Mr. Lukach provided to the Committee charts he had prepared sent under separate cover. There was a period of general discussion on this proposal.

Article 2 - Mr. Moss presented his proposal to the Committee. In response were comments from the members of the Board of Health who were all present. Other residents spoke on behalf of or offered general comments on Article 2. Mr. Tozeski and Mr. Howland also provided comments. There was a period of general discussion on this proposal.

Articles 3 to 16 – Mr. Morgado provided a brief explanation on each of the articles.

Articles 17 & 18 - Mr. Howard, Mr. Tozeski and Mr. Howland presented these articles which seek funding for the construction of a new water treatment facility. There was a general discussion on this proposal.


