WEEKLY REPORT OF CONFIRMED CASES OF COVID-19 IN THE TOWN OF SHREWSBURY

The Town of Shrewsbury has been notified by the Central Massachusetts Regional Public Health Alliance ([CMRPHA](#)) that additional Shrewsbury residents have tested positive for Coronavirus (COVID-19). Public Health Officials are working closely with the individuals and will notify others that the individuals may have been in contact with. CMRPHA will continue to work with the Massachusetts Department of Public Health to ensure any affected residents are properly monitored, quarantined and isolated as each case dictates.

Positive cases in the Town of Shrewsbury as of **April 29, 2022: 7,687 (+113)**
Positive cases in the Town of Shrewsbury as last reported, **April 22, 2022: 7,574**
14 Day Increase (from 4/16/2022 to today): + 167
30 Day Increase (from 3/31/2022 to today): + 334
60 Day Increase (from 2/29/2022 to today): + 486

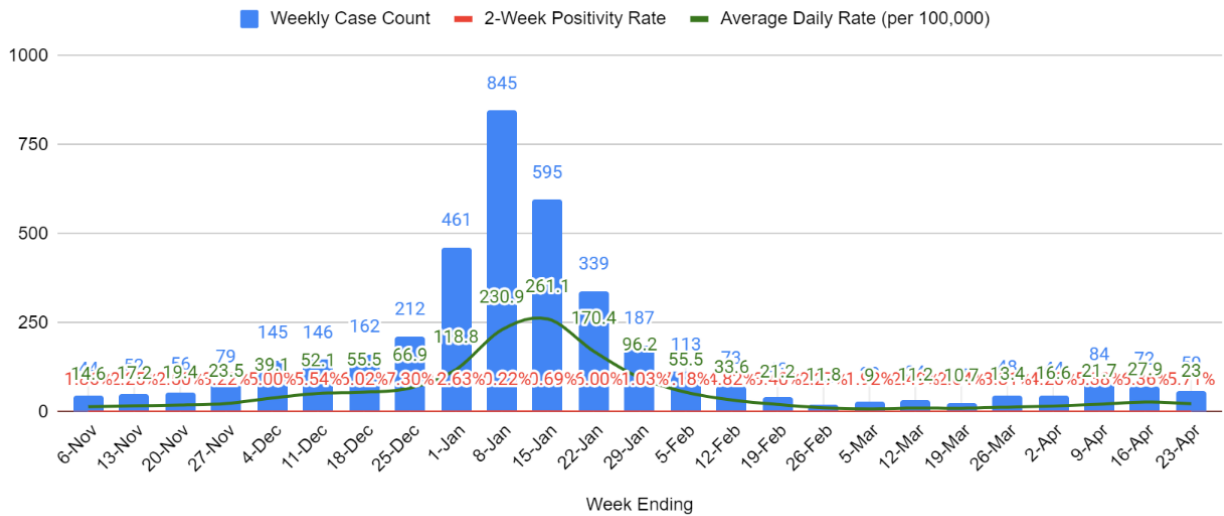

All Residents	91%	81%	51%

*Effective 3/18/2022, the Town will report vaccination data only as a % of the population.

All residents 5+ who live, work, or study in Massachusetts can now be vaccinated. People ages 5-17 can only get the Pfizer vaccine. People age 18 and older can get any vaccine. All residents 18+ are now eligible for a Moderna booster shot, and 12+ are eligible for a Pfizer booster shot, 6 months after receiving the second dose of a Moderna or Pfizer COVID-19 vaccine. All residents 18+ who received a single dose of the Johnson & Johnson COVID-19 vaccine are eligible for a Johnson & Johnson COVID-19 booster shot.

The Central Massachusetts Regional Public Health Alliance has provided the following data for Shrewsbury. The Town of Shrewsbury is now in the **Green** category.

- Group** **Population of 10,000 to 50,000**
- Grey** Less than or equal to 10 total cases
- Green** Less than 10 average cases per 100,000 residents AND greater than 10 total cases
- Yellow** Greater than or equal to 10 average cases per 100,000 residents OR greater than or equal to 5% positivity
- Red** Greater than or equal to 10 average cases per 100,000 residents AND greater than or equal to 5% positivity
