DAILY REPORT OF CONFIRMED CASES OF COVID-19 IN THE TOWN OF SHREWSBURY

The Town of Shrewsbury has been notified by the Central Massachusetts Regional Public Health Alliance ([CMRPHA](#)) that additional Shrewsbury residents have tested positive for Coronavirus (COVID-19). Public Health Officials are working closely with the individuals and will notify others that the individuals may have been in contact with. CMRPHA will continue to work with the Massachusetts Department of Public Health to ensure any affected residents are properly monitored, quarantined and isolated as each case dictates.

Positive cases in the Town of Shrewsbury as of today, **April 2, 2021: 2,776 (+4)**

Positive cases in the Town of Shrewsbury as last reported, **April 1, 2021: 2,772**

State designation: **Moderate Risk (Yellow) Community** as of April 1, 2021

7 Day Increase (from 3/27/2021 to today): + 56

14 Day Increase (from 3/20/2021 to today): + 114

30 Day Increase (from 3/4/2021 to today): + 225

60 Day Increase (from 2/2/2021 to today): + 498

Residents in [Phase 1 or Phase 2, Group 1](#) (individuals age 75+ or individuals accompanying a 75+ resident), [Phase 2, Group 2](#) (ages 60+, those with two or more medical conditions, and residents and staff of low income and affordable senior housing), [K-12 Educators, Child Care Workers and K-12 School Staff](#), and [certain workers](#) are eligible to get the COVID-19 vaccine now. **All residents can preregister** to book an appointment at a mass vaccination site

at mass.gov/COVIDVaccine or dial Mass 2-1-1 for assistance. Residents age 60+ may call the Shrewsbury Senior Center at 508-841-8640 or Mass 2-1-1 for assistance.

Appointments will be offered based on eligibility and available appointments nearby. It is expected that more sites will come online as part of the preregistration process in April.

Timeline for remaining groups:

- April 5th: Residents 55+ and residents with one [certain medical condition](#)
- April 19th: General public ages 16 years of age and older

The full timeline is available at mass.gov/COVIDVaccinePhases. The Administration has received assurances from the federal government that an increased vaccine supply will be available to states soon. Depending on supply, it could take weeks for people to be notified that an appointment is available at a mass vaccination site.

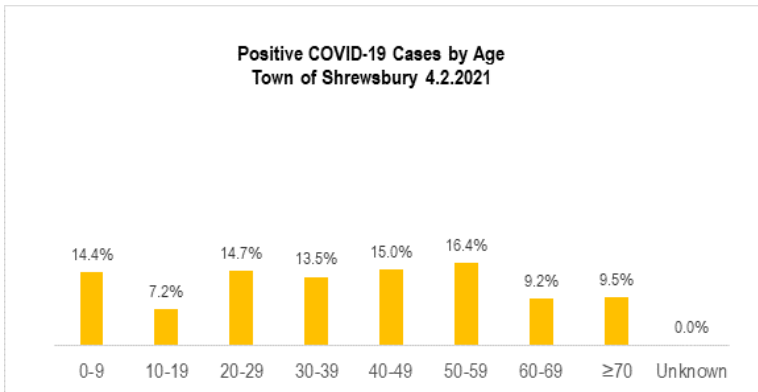
The Town is doing everything it can from a public health and public safety standpoint to reduce the spread and ensure the continued operations of all essential services. The Commonwealth has launched “Stop the Spread”, a strategic testing program in communities across Massachusetts that have continued to see a higher number of residents testing positive for COVID-19 and is providing [free testing](#).

The Town of Shrewsbury is committed to keeping the public informed during this period of the Coronavirus (COVID-19) pandemic. The Town will report positive cases each weekday by 4:30PM*. Weekend cases and vaccination data will be included in the Monday release. The Town Manager's Office will update the public with any new developments or changes in Town operations including confirmed cases of COVID-19 in Shrewsbury, in the following order:
