DAILY REPORT OF CONFIRMED CASES OF COVID-19 IN THE TOWN OF SHREWSBURY

The Town of Shrewsbury has been notified by the Central Massachusetts Regional Public Health Alliance ([CMRPHA](#)) that additional Shrewsbury residents have tested positive for Coronavirus (COVID-19). Public Health Officials are working closely with the individuals and will notify others that the individuals may have been in contact with. CMRPHA will continue to work with the Massachusetts Department of Public Health to ensure any affected residents are properly monitored, quarantined and isolated as each case dictates.

Positive cases in the Town of Shrewsbury as of today, **April 16, 2021: 2,872 (+4)**

Positive cases in the Town of Shrewsbury as last reported, **April 15, 2021: 2,868**

State designation: **Moderate Risk (Yellow) Community** as of April 15, 2021

14 Day Increase (from 4/3/2021 to today): + 98

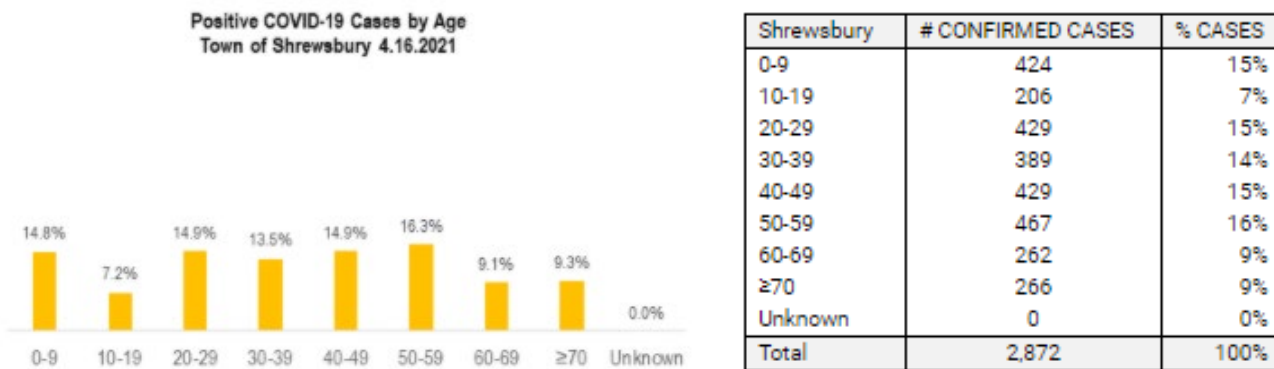

The Town of Shrewsbury is committed to keeping the public informed during this period of the Coronavirus (COVID-19) pandemic. The Town will report positive cases each weekday by 4:30PM*. Weekend cases and vaccination data will be included in the Monday release. The Town Manager's Office will update the public with any new developments or changes in Town operations including confirmed cases of COVID-19 in Shrewsbury, in the following order:
